#### **COUNSELING ADVOCACY**

The counseling program at S.A.F.E. Place served over 150 survivors and their children in 2017 by a master's level therapist, free of charge. Counseling offers a safe, healing space to survivors who otherwise may not be able to afford counseling or cannot access counseling confidentially due to being on their abuser's insurance.

In 2018, we are continuing to grow our counseling services by adding four master's level counseling intern positions to meet the growing demand for more supportive services for survivors and their children.

#### **CHILDREN'S ADVOCACY**

This past year marked the relaunch of the children's program at S.A.F.E. Place. In February of 2017, the program was able to provide an array of new services and reach 193 youth clients in shelter. Families were able to access youth friendly activities that promoted spending time together and meeting new friends. Residential clients were invited to attend homework time in which they had the opportunity to meet with an advocate to work on assignments in a quiet environment.

For children and teens that have experienced trauma due to witnessing domestic violence, they have the ability to seek counseling services. Through counseling, these young people can receive domestic violence education, learn healthy coping strategies for dealing with trauma, and create an individualized safety plan that is tailored to their needs.

Over this past year, the children's program has been able to provide many resources to children and their families. This program plans to continue expanding to offer a variety of services and reach more survivors of domestic violence.



# **FINANCIALS**

#### **REVENUE AND EXPENSES**

With a new leadership team in place, Fiscal Year 2017 was a year of building and establishing a baseline for operations. About 2/3 of S.A.F.E. Place's \$972,000 reve-





nue comes from a variety of federal, state, and local foundation grants. The remaining 1/3 is a mixture of fundraising events, corporate and civic gifts, as well as individual contributions made throughout the year. More than 3/4 of S.A.F.E. Place's expenses directly support victim programs, including emergency shelter services, legal advocacy,

counseling, and children's programs. 14% of expenses were allocated to administrative costs and 9% to fundraising activities, with a cost ratio of about 0.27.

"I talked with a client who was leaving the shelter to go home to her abusive husband. I asked her if she felt she was going to be safe, in which she replied she felt she would be okay.

However, she was concerned that her abuser might hit her hard enough to break another bone in her face as he had done before. I discussed with the client that once an abuser becomes physically abusive towards his/her significant other, the chance of it happening again often increases since the abuse is likely to escalate over time.

I told the client that I was concerned for her life and offered to safety plan with the her. I assured her that she could always call us whenever she needed to get away from her abusive husband, and we would always have an available bed for her to stay in if she chooses to come back and receive safe shelter services."

#### **LEGAL ADVOCACY**

Our three legal advocates at S.A.F.E. Place serve Calhoun, Eaton, and Barry Counties, assisting victims through the criminal and civil legal system. They work closely with the Prosecutor's Office, Personal Protection Order Office, and Legal Services. Each week, they meet clients at preliminary exams, pre-trials, and jury trials, assisting and supporting them as needed.

Supervised by Legal Services in a collaborated effort, our Calhoun County legal advocate also may assist clients in The Divorce Clinic. The Divorce Clinic allows many victims of domestic violence who qualify and are low income, guidance and support in filing for a proper divorce who would not otherwise be able to afford an attorney.

The coordinated efforts in place with the Prosecutor's Office, Personal Protection Order Office and Legal Services allow S.A.F.E. Place to empower and address victims'

safety and legal concerns.
